Terms & Conditions

Welcome to Rewriting the Code! These terms and conditions (the “Terms and Conditions” or “Terms”) govern your usage of the rewritingthecode.org website, including any subdomains, sandbox, demo, integration environment, blog, or application hosted under the rewritingthecode.org root domain (collectively referred to as the “Website”). These Terms along with the Team RTC APP End User License Agreement (“EULA”) also govern your usage of our mobile application (the “App”). The App and Website together may be referred to as the “Services”.

By downloading or using the App or by visiting or using the Website, you hereby agree that these Terms are binding upon you. Therefore, we recommend reading these Terms before downloading the App or continuing to use the Website.
